**KTR's Justification of Collector Attack Draws Strong Criticism from Komatireddy Venkata Reddy**

Zaheerabad, November 14 (TSIT) - State R&B Minister Komatireddy Venkata Reddy has strongly condemned BRS working president K. Taraka Rama Rao (KTR) for justifying the recent attack on a collector and government officials. Speaking at a press conference in Zaheerabad, Venkata Reddy described KTR's defense of the attacker, Suresh—identified as a rowdy sheeter involved in a rape case—as shameful. The Minister also criticized Chief Minister K. Chandrashekar Rao (KCR) and KTR for their lack of awareness during the recent power outages in the state. He accused the ruling BRS leadership of attempting to return to



power with the sole aim of continuing their alleged corruption and mismanagement. Venkata Reddy outlined Congress's plans if they come to power, including the establishment of integrated hostels in every district, with a budget of 5,000 crores, as part of the "Young India" initiative. He assured farmers that promises made to them would be fulfilled, particularly with regard to timely agricultural support. The Minister also emphasized plans to repair roads in remote areas and mentioned a pilot project for filling potholes, starting with the road leading to the

**Brutal Murder of Mother and Son Shocks Sangareddy District**

Sangareddy (TSIT) - A brutal murder of a mother and son in Bonthapalli Sangareddy district, has created widespread shock. Nagaraju, a man from Bihar, is accused of fatally stabbing Sarojadevi (50) and her son Anil (30) on a road in Veerabhadranagar early this morning. The victims, who were reportedly from Uttar Pradesh, were attacked in broad daylight. Nagaraju confessed to the murder, citing an old feud as the motive. Locals reported that Nagaraju claimed the victims were responsible for the death of his 2-year-old son, which he believed was caused by an attack from Sarojadevi and Anil. In retaliation, he allegedly killed them.
