## First Telangana State Conference for Women in Police from August 20



Hyderabad, TSIT BUREAU: The RVBR Telangana Police Academy will host the first-ever Telangana State Conference for Women in Police from August 20 to 22 at its Hyderabad campus. Around 400 to 450 police officers from all ranks across the state will take part in the event aimed at open dialogue and knowledge sharing. Director General of Police Dr. Jitender said the conference will help women police personnel work more effectively and give them a platform to openly express their concerns.
